

As you may already know, Missouri Girls Town has been working diligently over the last year to increase our capacity. This comes during a time where high school graduation rates in the State of Missouri continue to drop, and we find more youth in need of our therapeutic services. As a QRTP (Qualified Residential Treatment Provider) for the State of Missouri, we have achieved Trauma Informed certification and are now utilizing the Trauma Informed modality TBRI© (Trust Based Relational Intervention) to build trust-based relationships with the youth we serve so we can more quickly and effectively get to know our clients on an interpersonal level so we can help them address their trauma in a productive and healing way.

In January 2024, we saw record-breaking low temperatures which caused a pipe to burst and with the melt, eventually flood our higher-level house. All the while, we were beginning to increase our campus census from 22 youth residents to 25 with the eventual goal of caring for 34 youth clients. The same week that we began moving clients according to their level of care into our McClain-Williams House, a pipe burst and flooded Hope House.

Thankfully, we had not yet admitted new residents which allowed us to essentially reshuffle clients to keep them housed safely on our campus. We know that each placement is an additional trauma for the youth we serve and were very fortunate to be able to keep them in this placement and care team. Over a month later, we have now made the necessary repairs to Hope House and are ready to increase capacity. This included repairing the pipe and replacing drywall, ceiling, flooring, and mold mitigation with a \$200,000 price tag. Our insurance enabled us to move quickly to make the necessary repairs but left us with an unexpected deductible payment. Now, we appeal to our founders at GFWC to help keep us on track for this growth which comes with increased food and housing costs as well as staffing for the around-the-clock care for the youth we serve. In a time where there simply aren't enough placements for females in the state of Missouri, we humbly ask for you and your clubs to come together so we can meet this dire need for Missouri's youth. With your help, we can stay on track with our current growth plan to offer our exceptional therapeutic treatment to at least 12 additional children by the end of April.


You can help us reach this goal by making plans to attend our Patron's Breakfast event to take place on Wednesday April 24th from 7am-8:30am at 4747 Elk Park Drive in Columbia, Missouri. We're excited for our supporters to hear from our keynote speaker Syreta Tosen who shares her story of resilience and humanity. This breakfast event is free to attend, however, we encourage you to open up your hearts to youth in need, by making a suggested donation of \$100 at this fundraising event so we can maintain our trajectory of growth to meet the complex needs of today's youth in foster care. We continue to offer 50% Missouri State Tax Credits through our Youth Opportunities Program project to enable donors to maximize their donation while minimizing their out-of-pocket cost.

Deanna Barger MPA Director of Development Missouri Girls Town Foundation Inc. I just wanted to let you know that we held the Reading Awards Program today at Missouri Girls Town. 15 out of 16 girls read at least 2 books and 6 girls read between 20 and 54 books. We ask the girls to turn in a brief "book report" to their counselors to validate their numbers. We awarded 65 prizes and \$155 in Walmart gift cards. This compares to the event in May when we awarded 41 prizes and \$50 in Walmart gift cards and 13 girls read between 2 and 45 books with only 2 girls reading more than 20 books.

The girls have been loving the following items and I would encourage the donation of these items or else

- Walmart gift cards in increments of \$5 and \$10
- decorative boxes to store some special personal things
- Books for teenagers Teen romance, historical fiction with some romance no violence, if possible
- playing cards
- stuffed animals
- markers
- theatre size boxes of candy (donate closer to the next event) so it doesn't get too old)

The president and/or corresponding secretary could send out periodic messages with updates on members in need, fundraisers, social activities, committee meetings/reports, and more.

And, how about planning a social, a luncheon, before your first meeting in September – not only for fun but to distribute your new yearbook, pass out t-shirts ordered, etc.

All these possibilities and more help to keep not only your members connected and involved throughout the summer but also provide opportunities to reach out to others to help grow your membership.

#### Who Is Going to the GFWC Annual Convention in Chicago?

The convention begins on Friday, June 28, with LEADS training during the day and the Illinois State Banquet in the evening. Saturday, June 29, the Opening Ceremony & Business Session kicks off with the State Presidents and Presidents-Elect (or other designated leaders) carrying the flags from each state. What an impressive beginning to the convention! On Sunday, the election for the 2024-2026 GFWC Executive Committee will take place throughout the day as the business sessions continue. Monday's highlights include the Installation, Banquet, and Reception. The convention concludes after the festivities on Monday evening. Throughout the days on Saturday, Sunday, and Monday will be business sessions, resolutions, workshops, and other activities.

Workshops are typically presented by the following chairmen/committees: Membership, Leadership, Fundraising & Development, Communications/Public Relations, Signature Program, & Juniors' Special Program. One morning will be the ESO breakfast with a featured author, and regional luncheons will also be held. (We are the Mississippi Valley Region.) Awards are given throughout the convention, and it's always exciting to hear "Missouri" for an award. State photos are taken one night with everyone from the state sitting with the GFWC International President and Director of Junior Clubs. There is often a service project for members and an Affiliates Luncheon to hear from many of our Affiliate Organizations. It's an action-packed few days where you will learn a lot and have the opportunity to network with members from other states. You don't want to miss all these opportunities.

Will you be attending as a voting delegate? Each club is allowed 2 voting delegates per club. If your club has more than 20 members, you get an additional delegate for each additional 10 members or major fraction thereof. Here are some examples:

8 members=2 delegates, 16 members=2 delegates, up to 25 members=2 delegates,

26-35 members=3 delegates, 36-45 members=4 delegates, 46-55 members=5 delegates, etc.

In addition, State Chairmen corresponding to the 5 GFWC Community Service Programs (Arts & Culture, Civic Engagement & Outreach, Education & Libraries, Environment, & Health & Wellness), GFWC Signature Program, GFWC Juniors' Special Program (Advocates for Children), Communication/Public Relations, Fundraising & Development, Leadership, Legislation/Public Policy, Membership, and WHRC may all register as chairman of these areas and don't have to count as a club delegate.

When you fill out your convention registration form, list your role as Club Delegate, Education & Libraries Chairman, Leadership Chairman, etc.

#### **ARTICLE X: DISTRICTS**

#### **CURRENT**

Section 1. NAME. The GFWC of Missouri, Inc. shall be divided into nine (9) geographic areas to be called Districts, composed of the following groups of counties:

**FIRST DISTRICT**: Andrew, Atchison, Buchanan, Caldwell, Clinton, Daviess, DeKalb, Gentry, Harrison, Holt, Livingston, Mercer, Nodaway, Worth.

**SECOND DISTRICT**: Cass, Clay, Carroll, Jackson, Johnson, Lafayette, Platte, Ray.

**THIRD DISTRICT**: Adair, Chariton, Clark, Knox, Lewis, Linn, Macon, Marion, Putnam, Schuyler, Scotland, Shelby, Sullivan.

**FOURTH DISTRICT**: Audrain, Boone, Callaway, Lincoln, Monroe, Montgomery, Pike, Ralls, Randolph, Warren.

**FIFTH DISTRICT**: Bates, Benton, Camden, Cole, Cooper, Henry, Hickory, Howard, Maries, Miller, Moniteau, Morgan, Osage, Pettis, Saline, St. Clair.

**Section 5. QUORUM.** The quorum for the Convention shall be voting delegates representing 20 percent of Clubs in Active membership and from at least three (3) Districts.

Rationale: To allow for a reasonable quorum with the restructuring into four districts.

#### **ARTICLE V: OFFICERS**

#### **CURRENT**

**Section 2. ELIGIBILITY**. Only members with a current minimum of two years Active Club participation shall be eligible to hold office. A qualified candidate must have proven leadership experience endorsed by her Club and District. No more than two elective Officers may be from the same District.

Amend the last sentence by deleting "two" and inserting "three (3)" before "elective Officers".

#### **AMENDED WOULD READ**

**Section 2. ELIGIBILITY**. Only members with a current minimum of two years Active Club participation shall be eligible to hold office. A qualified candidate must have proven leadership experience endorsed by her Club and District. No more than three (3) elective Officers may be from the same District.

#### **ARTICLE V: OFFICERS**

**Sec. 3. TERM.** The term of office shall be two years, and Officers must maintain Active Club membership. Officers shall serve from the adjournment of the Convention in which they are elected to the adjournment of the Convention in which their successors are elected. No Officer shall serve more than one term in the same office, with the exception of the Treasurer, and no member may hold two offices at the same time. Any Officer who has served more than one year shall be considered to have served a term. The outgoing President, President-elect and Director of Junior Clubs (when elected) shall be the official representatives to the General Federation.
